

### **LEGISLATIVE** PRIORITIES FOR NEW YORK STATE GRANGE 2011

**Agriculture and Environment** 

\* Supports needed revisions to a federal milk pricing system to include regional order pricing, Class I base floor price of \$18 per hundredweight (cwt), low interest loans for diary farmers, and a supply management program as endorsed by dairy groups. \* Supports changing regulations of United States Department of Agriculture that makes food recalls mandatory and not optional for the manufacturer/processor and to include the identity of the manufacturer/processor and where the food products were distributed

Urges continued appropriation of Environmental Protection Funds (EPF) for conservation projects and request the State Legislature to continue funding the New York State Agriculture Environmental Management Program (AEM).

### Education

\* Supports a true "wealth (Continued on page 3) (Continued from page 1) Thousand Islands.

- · Legislative conducted several regional meetings attended by local, state, and sometimes federal legislators to share our Grange legislative goals. The culmination of their work took place at our State Session with the adoption of over 100 resolutions of local, state and national interest.
- · Youth held two successful weekends, both winter and spring, with workshops on code reading, program planning, and community service, as well as public speaking contests. Public Speaking winners participated in the Northeast Youth Conference in Massachusetts and came home with the First Place Best of Show who will represent the Northeast Region at the National Grange's Evening of Excellence. An excellent drill team also participated in the Northeast competition and were proud to place third.
- · Information continues to issue our State Grange publication, the Empire State Granger, with color photos of Grange Family activities on the front and last pages. A Special Issue, highlighting all Grange department activities was distributed at the Winter Farm Show, Empire Farm Days, the NYS Fair, and at several county fairs and community days, and serves as an excellent membership tool to attract new people.
- · Membership/Leadership have completed work in revitalizing a Subordinate and Pomona Grange in Washington County, and are continuing work revitalizing Granges in both Cattaraugus and Onondaga Counties. The crowning glory is the reorganization of the Putnam-Westchester County Pomona Grange Family in southeastern New York with 40 new members! Officers have been elected and installed, major committee chairs appointed, and they are currently working on two legislative issues to be brought to the 2011

State Session. Additional wonderful news - a brand new Subordinate Grange is being organized in Niagara County as a result of the organization of Lockport-Oakfield Junior Grange two months ago.

Special Deputies have been working with Granges who have internal concerns with the hope of revitalizing them to be an active Family organization again. Special Committees and Chairs were at work at our Annual Session reviewing, debating, and recommending resolutions of importance for the delegate body. The results of their deliberations saw 22 resolutions of national concern brought forward to the National session for consideration.

What are some of the new things going on with the New York State Grange?

Our website coordinator continues to update the New York State Grange website with Family related news -Junior Grange Camp Week, Youth Activities and Weekends, and several Family Activities Committee doings. We continue to add items of potential interest to Grange members. The recent addition is the New York State Agricultural Mediation Program which helped over 900 people last year from the agricultural community and addresses different conflicts and disagreements. Mediation is not just of an agricultural nature and can include small claims and unpaid bills, bank loans, Family issues of child custody and parenting plans, neighbor complaints, to name just a few. Visit our website at www.nysgrange.org for fur-

ther details. We are currently evaluating our Student Loan Program (Family issue) to bring the student applications and cosigners forms up to date.

We now live in an advanced technological world and must keep our records up to date. After a good 25 year rela-

tionship with the National

Safety Council, the New York State Grange has decided to discontinue the Defensive Driving Program. It all boils down to economics. We would still need to charge a \$25 fee for the course, but other groups out there such as retiree groups et. al. now offer the course for as little as \$10 per person, and there is no affiliation with the group required and no age restrictions either (Family). The course is also offered online with little to no cost to the individual. However, we strongly encourage Granges to continue sponsoring the course as a community service project, especially for those unable to take the course online. Feel free to contact Headquarters with suggestions for groups who now offer the low cost course.

At the turn of the New Year, the New York State Grange will sponsor the 2011 Northeast Leaders' Conference at the Latham Holiday Inn Express, just north of Albany, from January 7 – 9. Participants are invited for New York State and our associate states in New England - Connecticut, Maine, Massachusetts, New Hampshire, Rhode Island, and Vermont. We are holding workshops for several Grange departments: Family Activities, Youth, Junior Grange, Legislative, Lecturer, Information, Membership/ Leadership, and Community Involvement/Service. Each department will bring valuable information to be shared with your Grange committees at home. All Grangers are most welcome to attend the entire weekend conference,

but if you wish to get the most value for your dollar, consider attending the Saturday session on January 8th as a commuter. National Master Ed Luttrell will be conducting a workshop on Grange Teamwork, and Barbara Jones, the new National Grange Communications Director, will hold a seminar on how both Grangers and Granges can better communicate with each other. The highlight of Saturday's program will be a discussion and debate held by the Commissioners of Agriculture of both New York and Connecticut about "The Future of Agriculture in the Northeast." This will feature our own Commissioner, Brother Pat Hooker, and Connecticut's Commissioner, Brother Phil Prelli, who visited our Session in October as the National Grange Representative. You won't want to miss this day, Saturday, January 8th. There is a small registration fee for commuters, and both lunch and dinner will be available for those who choose. Your Pomona Grange has been notified with all the necessary information needed as well as it can all be found on the State Grange website.

On the weekend of September 24 - 26, I was privileged to attend a National Grange sponsored Pomona Grange Summit in western Pennsylvania. Planned for the east's most populous Grange states - New York, Pennsylvania, and Ohio participants also attended from four New England states, too. A great deal of serious discussion was held about the role of the Pomona (Continued on page 3)

(Continued from page 2) Grange in our organizational structure, and serious debate took place over questions of what top three things should an ideal Pomona have, how many Granges should a Pomona have, how often should a Pomona meet, and how do you revitalize a Pomona Grange? Should you work at the Pomona level first which, in turn, should revitalize its Subordinates, or should vou work on the Subordinates first which will then revitalize the Pomona? This last point needs a great deal more discussion. A summary of this Pomona Summit will be sent to each Pomona Grange to discuss and debate and, hopefully, this will lead to an informal State get-together to allow New York Grangers to contribute input into revising the Pomona Grange structure and its role in our Fraternity. As the current National Grange Digest of Laws for the Code of the Pomona Grange reads, and I quote, "If the number of Subordinate Granges included in the jurisdiction of a Pomona falls below two, the State Grange shall readjust the jurisdiction."

Many are wondering about the National Grange assessment to finance future National Sessions. In 2007, delegates to National Grange adopted a policy that points out that the National Grange Annual Session belongs to every Grange member across this great nation of ours. When the National Master, or other National personnel, is called to give testimony to Congress, or a lesser federal agency, they express the National Grange's point of view or legislative policy in question. They are speaking for not only 7th Degree members, but all Grangers across this land no matter what Degree affiliation they have. Thus, each Grange member should be proud to do their part to financially support the National Session. An assessment of \$1 per member per year was adopted, and the

New York State Grange decided to utilize fundraisers to meet our annual assessment rather than raise dues or bill each Grange. When you learn of these fundraisers, we strongly encourage the support of Grangers and friends. Our National Hosting Fundraising Committee is making plans for a Penny Social in **Dutchess County on February** 26, 2011. State Officers and Directors have been asked to provide both theme baskets and gift prizes for this event. Plans for two bus trip, one to Lancaster, Pennsylvania, this December and one to Newport, Rhode Island, next spring are also in the making. Details are available at Headquarters in Cortland. The Committee is also sold "used delights new to you" at their special table as well as the new FAC Cookbook and Grange Emblem Slate Trivets (hot plates). If you are interested in either item, please contact Headquarters to reserve or purchase a trivet or the new cook book.

### (Continued from page 1) Legislative priorities adjusted formula' to address the inequity in state aid awarded to poor and affluent school districts which is favorable to high need rural

districts.

- \* Urges state and federal legislation to set guidelines of outlining the many forms of bullying in our schools and to take appropriate actions in making bullying a punishable offense with age appropriate punishment.
- \* Seeks legislation for the immediate establishment and utilization of alternative assessments of learning standards that could be used for successful completion of state learning requirements with the provision of a high school diploma, subject to reasonable state review.

#### Health

\* Recommends increased efforts and sanctions against individuals, agencies, andhealth providers who are found guilty of Medicare and/ or Medicaid fraud.

### **State Government**

- \* Supports a timely passage of the State Budget, elimination of the "3 person control" (Governor, Senate Majority Leader, and Assembly Speaker) in its development and an imposition on all members of the Legislature for each day of a late budget past April 1.
- \* Calls upon the Governor and NYS Legislature to inventory and review existing mandates to local governments and schools to work towards mandate relief legislation. Future mandates to be fully funded by NYS.

#### **Consumer Protection**

\* Supports empowering the newly created Consumer Financial Protection Bureau (CFPB) to ban banks, mortgage lenders, credit card companies and any other financial institutions from charging consumers fees for paper statements.

### Resolutions passed at State Grange 2010 AGRICULTURE & ENVIRONMENT

#### New York State Grange....

- proposes that any attempt to amend the Labor Law in relation to farm workers be very carefully considered in concert with extensive research into the exact nature of
- opposes the repeal of the Capper-Volstead Act of 1922. - supports Farmers' Markets, family farms and Community Supported Agriculture (CSA's) producing and selling homegrown agricultural products.
- suggests that state regulations be implemented to allow a dairy or farm with a permit to sell and deliver unpasteurized milk in a suitable vehicle to a market site and/or allow an agent at the market to hold and properly handle any pre-ordered and pre-paid milk for a customer pick up.
- favors an indefinite moratorium in the hydrofracking process, the horizontal drilling for natural gas, until it can be proven by New York State Department of Environmental Conservation and the **Environmental Protection** Agency that the hydrofracking process is not a threat to our natural resources of water and air or to our human health.
- supports the efforts of the agencies involved in the control of the Asian Carp infestation in the Mississippi River and Great Lakes system, and further, that the other states and Canadian

(Continued from page 3) provinces that border these systems be encouraged to be actively involved in the programs that are currently in place and any future measures to be taken to protect the fisheries of the Mississippi River and Great Lakes. - supports the Department of Ag & Markets and the Farm Wine Producers' efforts to reinstate sale of wine by the glass at fairs, firemen's carnivals, church lawn fetes, etc., and urges the New York State Legislature to pass bills or legislation that would allow licensed wineries and farm wineries to sell wine by the

- glass at these events.

   urges and supports the establishment of additional mobile slaughter houses which can be moved and set up in a 24-hour period with the following units: one for slaughter; one for setting up the cuts of meat; one for refrigeration; one for waste; and one for a United States Department of Agricultural office, lounges, and showers so the meat can be inspected and approved.
- opposes the Department of Environmental Conservation's (DEC) proposed regulation that restricts the use of outdoor wood boilers/ furnaces in rural New York State
- actively seeks an at-large position on the New York State Beef Industry Council, by nominating a representative who would meet the Council's qualifications for a member who would maintain the board's objective of a well-rounded representation of the beef industry.

### Reaffirmed policy...

- opposes any ban on sale of dairy products from cows injected with bovine somatatropin (BST).
- supports changing the United States Department of Agriculture (USDA) regulations regarding food recalls that will: (1) make it mandatory to inform the public and local health officials of the

recall of tainted food products, who the manufacturer/processor is and where the food products have been distributed. (2) require the USDA website to be more user-friendly so this information can be easily obtained by the general public. (3) require all recalls of tainted food products be made mandatory, not voluntary, by the manufacturer/processor.

- opposes any cutbacks in the federal daily inspections of meat processing plants, further that we oppose selfinspection of meat processing plants.
- opposes local regulation of pesticide usage and notification legislation.
- opposes legislation prohibiting the commercial and residential application of pesticides for pest control.
  opposes the importation of
- opposes the importation of animals, meat, and meat products into the United States from any country having bovine spongiform encephalopathy (BSE) until scientific data shows the supply is safe.
- opposes expanded regulation of wetlands less than 12.4 acres or any other wetland regulations that further restrict the rights of property owners.
- urges National Grange to use its influence to allow best management practices in national forests.
- recommends that State and National Granges monitor closely the proposals of the Great Lakes Basin and its possible adverse impact on the agricultural industry, and further to become involved in decision making as local and state governments address adoption and implementation of such regulations.
- supports legislation which would legally allow people to defend themselves from an attack by a rattlesnake or any other animal without concern of retribution from government authorities.
- supports legislation that requires the Department of Environmental Conservation

(DEC) to notify local residents of wild animal releases so they can be alerted to necessary safety awareness measures.

#### **EDUCATION**

New York State Grange.... - supports the preservation of the Head Start Program. - supports legislation that would require legal action for bullying within our schools. - supports a true "wealth adjusted formula" model that includes the following points: (1) elimination of the .65 floor that is built into the Income Wealth Index as most small and rural school districts have a wealth index well below .65, thus the Income Wealth Index penalizes High Need Rural Districts. It does not acknowledge the true level of need. (2) elimination of the "shares" approach to the current distribution of school aid, to address the higher levels of poverty and a greater disparity between poor and affluent school districts. It is an issue of fundamental fairness and a true wealth adjusted formula should be based on the ability to pay. - urges our state government

- to introduce legislation that would make the act of bullying another person, with positive proof of bullying, a legal punishable offense with age appropriate punishment and further, that the Department of Education and/or Board of Regents set guidelines that outline all forms of bullying tactics, including the use of physical, verbal and cyber abuse on social networking sites on the Internet and the appropriate actions that should be taken in dealing with the students who are initiating the bullying and the necessary psychological assistance for those who are recipients of these bullying
- supports the concept of a statewide standardized testing program.

### Reaffirmed policy...

- seeks legislation for the immediate establishment and utilization of alternative assessments to determine the successful completion of state learning standards subject to reasonable state review and the provision of a local high school diploma for school districts that provide alternative courses in multiple assessments responding to individual students' needs. - seeks changes in state law entitling school districts and BOCES to full reimbursement for approved pre-school (3-5 year olds) special needs programs within the next school year.
- supports an amendment to Article 221 of the New York State Penal Law to address the possession of and intent to sell marijuana upon school grounds, which will give police departments and courts across New York State more power in keeping marijuana out of schools.
- encourages federal legislators to initiate legislation protecting the Upward Bound Talent Search designed to benefit low income students seeking college educations. - appeals New York State public officials to implement new measures for financing public education, including the following suggested actions: (1) ensure equity in a State Aid formula for funding public education based on the taxpayers' ability to pay; (2) decrease the revenue raised from tax sources based on the value of dwellings; (3) refrain from imposing state mandated requirements upon school systems without corresponding state funding; (4) adjust the formulas on revenues earmarked as aid to education from state lottery and other future gaming activities so that the annual percentage is substantially increased from the current level; (5) maintain the enhanced STAR exemption for the town's neediest citizens, but also increase the STAR (Continued on page 5)

(Continued from page 4) exemptions for senior citizens specifically at all income levels; and (6) regain lost tax revenue from the above actions through income tax. - supports legislation to increase the unencumbered fund balance that school districts may maintain from year to year from two percent (2%) to five percent (5%). - suggests that the United States Department of Health, Education and Welfare and our New York State Department of Education continue to support planning which will teach children the positive effects of dealing with each other kindly and fairly and about the negative impact of verbal, emotional and physical abuse on individuals and the possible end results of violence, injuries and death.

#### FEDERAL ISSUES

New York State Grange....
- urges the New York State
Legislature and the U.S.
Congress to keep highway
signs predominately in English only.

- supports the enactment of the proposed Veterans Employment Assistance Act (S3234), or similar legislation, to provide our returning veterans with an opportunity for jobs, training and higher education.
- supports legislation that would direct the National Park Service and the Department of Justice to immediately restore the Mojave Desert Veterans Memorial Cross.
- opposes the elimination of Saturday mail delivery by the U.S. Postal Service (USPS). supports empowering the newly created Consumer Financial Protection Bureau (CFPB) to ban banks, mortgage lenders, credit card companies, and any other consumer financial institutions from charging consumers fees for paper statements. encourages more aggressive enforcement of existing Human Trafficking Laws and

further recommends that Grange members should use resources to educate themselves and others about the dangers of human trafficking.

### Reaffirmed policy....

- supports reforming campaign finance laws to include campaigns that are limited to 4 months prior to the primary and general elections.
- opposes cross party votes during a presidential primary election, further that there be one set date for a National Presidential Primary Election Day.
- supports government investment in research conducted by the private and public sector that will lead to the development and implementation of alternative technologies that reduce dependence on fossil fuel products.
- supports ethanol production in New York State.
- urges the U.S. Government to have the immigration laws strictly enforced including the deportation of illegal aliens.
   supports legislation that
- would establish regulations requiring all shipping lines to change their ballast water in the open sea to curtail introduction of foreign species into our domestic waterways.
- opposes the shipment of all grades of nuclear waste excluding low level medical radioactive waste on the St. Lawrence Seaway and to the importation of nuclear waste from foreign countries.
- supports legislation that would allow the federal government to charge fees for the use of the National Parks for producing movies, videos, ads and commercials, with the income to be used to maintain and make improvements to the National Parks and Monuments.
- urges the U.S. Congress to pass legislation which will give property owners some protection for the expanded scope of eminent domain procedures.
- supports the "Notch Fairness Acts" to compensate "Notch Victims" (born 1917–

1926) with an immediate \$5,000 settlement plus monthly compensation based on a post notch formula.
- supports legislation that would help stop the unauthorized sale of Social Security numbers and increasing the penalties for fraud that involves the use of another person's Social Security number.

#### GRANGE ISSUES

New York State Grange....
- Election Committee will be comprised of non-delegates, unless there are insufficient non-delegates to serve on the committee, thereby allowing delegates to be present for the business or guest speakers that take place while the Election Committee deliberates

- supports the closure of the Bible upon the Altar when the Grange is at recess at all levels of our organization from the Junior Grange to the National Grange.
- suggests the Legislative Conferences around the state include a session for attendees to discuss possible resolutions and how to write and present a resolution.
- strictly forbids the consumption or use of alcoholic beverages in any Grange building or on Grange property.
- delegates recommended the consideration of Myasthenia Gravis as a State Grange health project.
- urges the New York Association of Conservation Districts and the New York State Grange to work in close coordination and communication to insure the annual meetings of both organizations do not coincide.
- delegate body urges the New York State Grange Department Heads to coordinate their program year to run concurrently with other states in the Northeast Connection, to become effective as soon as can be arranged.
- delegate body encourages the New York State Grange

to become involved on Grange Day in the Demonstration Kitchen at the New York State Fair to promote Grange.

- recommends that National Grange either give a finite interpretation of clause #4 as to its actual meaning under Article XI 4.11.1 (H) regarding the sale of Grange real property, or remove it entirely to avoid Granges using it to bypass the intent of Article XI of having funds from real property sales given over to a State Grange trust fund.
- delegate body accepts the proposed New York State Grange Budget for the 2010-2011 fiscal year.
- delegate body accepts the submitted Officer and Committee reports for the 2009-2010 Grange year and commends these individuals on their accomplishments and, further, that the 2009-2010 reports from the New York State Grange Officers and Committees be printed in the Journal of Proceedings.
- delegate body accepts the New York State Grange Headquarters Report for the 2009-2010 fiscal year.
- delegate body accepts the amended New York Grange Headquarters Budget for the 2010-2011 fiscal year.
- recommends the password taken at a State Grange Session be made optional with the State Grange to determine a method or system of identifying 4th degree members at their session and, further, that the National Grange also determine an optional method of determining 4th degree membership other than the password.
- delegate body requests that the Master and Executive Committee investigate the possibility of moving the start of the State Grange session to begin on Wednesday, to end on Sunday, with the Youth and Junior Programs to be held on Saturday.
- recommends that members who have not yet received the appropriate degree be allowed (Continued on page 6)

#### HEALTH

- New York State Grange....
   recommends increased
  efforts to combat Medicare
  fraud
- supports legislation that would have a uniform expiration date stamped, not coded, on all processed foods.
- urges the United States Congress to pass legislation which will provide amputees with the same amount of coverage as Medicare, which covers 80% of the cost for a prosthesis.
- supports legislation that requires all newly constructed and remodeled public buildings have all ground level exits made handicap accessible to accommodate those people with physical disabilities to get out safely and efficiently.
- supports legislation that would cover military dependent children with Tricare health care coverage to a maximum age of 26.
- supports legislation that would extend Civilian Health and Medical Program of the Veterans Administration (CHAMPVA) health care coverage for eligible dependent children to the maximum age of 26.
- supports Assembly Bill A4176 or similar legislation that would establish a fresh fruit and vegetable program in schools encouraging the purchase of locally grown produce when available, through direct payments from the state to the school food services for the purchase of these products.
- opposes any legislation which automatically makes it legal to harvest a deceased person's organs and/or tissue under "presumed consent".

- supports the Emergency Services Volunteer Incentive Act which would help local communities reverse the

- decline in the number of volunteers of firefighter and emergency services personnel.

That in the early days of the Grange members wore aprons? The men wore pouches that were russet in color. The women members wore aprons of white. Maids' (Continued on page 9)

aprons were large like a work apron. Gleaners had the left corner brought up and fastened at the waist with the right corner held in the left hand so as to hold the gleanings. The matrons' apron was smaller. Both the white sashes and aprons were trimmed with red. The men's sashes were russet and fastened with an agate button.

The various colors were symbolic of Grange ideals. White represented faith, purity and sincerity. Russet is the general color of the plowed ground and so symbolized earth where sustenance came from. Red or scarlet suggested honor or royalty and also intensity and earnestness. Pink, the combination of red and white, signified the combination of both. but also youth, modesty and springtime. Gold represented truth and fidelity.

There are also specific instructions for the sizes of both the pouches and the sashes contained in the book Mentor in the Granges and Homes of P. of H. This book was written by A. B. Grosh and published by Clark and Maynard, New York, 1876. Grosh was one of the founders of Grange and served as its first chaplain. He also authored the "Odd Fellows Improved Manual."

The book tells of the formation and contains introductory remarks for the degrees. Lessons of the degrees are discussed at length with insight. Emblems of the degrees are also talked about.

The importance of education both in the Grange and homes is discussed. Libraries, reading rooms, newspapers, conversational meetings, discussions, and recreation such as fairs and music are mentioned to great extent. Holidays and church were important aspects of a Granger's life. Children were recommended to be welcomed and both young and old were expected to work together.

There are even some hints for the household and that the farm home should be peaceful and happy. Grosh stressed the importance of women throughout the book.


