FEDERAL ISSUES

- POLICY STATEMENT -

The Grange came into being over one hundred fifty (150) years ago. Soon it engaged in legislation as issues facing rural America came to the forefront, such as malpractice by railroads, the trusts, and the birth of the Extension Service and the formation of the Department of Agriculture.

Food and toy safety, debt reduction, health programs, Social Security, the environment, and other issues continue to attract the attention of the Grange. The Grange, standing on its solid foundation built more than a century ago with its strong family and moral values, can influence solutions to these problems in a positive way.

Crime, terrorism, undocumented immigration, and cessation of the "automatic granting of citizenship" to any child born to foreign nationals while touring/visiting the United States and national safety are of great concern to American citizens. The illegal use of drugs and human trafficking continue their adverse effects on society. Violence has entered the educational system, and penalties cannot be agreed upon. The cost of operating the penal system, homeland security and legal fees are skyrocketing. These issues present challenges to Congress, and the Grange fully supports enforcement of current laws and/or reforms, which are consistent with Grange policies.

Job growth is needed to enable American workers to be competitive with other major industrial powers. A modern, well-kept, and safe transportation system is essential to agriculture as well as the total economic system. The Grange believes in and strongly supports the dedicated highway fund. These funds should be protected against any "raiding" for budget balancing purposes. Attention to local roads and bridges is strongly supported by the New York State Grange.

The Grange also supports the Veteran's Employment Assistance Act and other Veterans' programs; and seeks solutions to address the problems within the Veterans Administration.

Social Security and Medicare are not entitlement programs and are especially important. It is critical that they be protected. For many of its recipients, it is their sole source of income and/or medical insurance.

Unfunded mandates issued by judicial proclamations, executive orders and legislative action must be curtailed.

The Grange understands the importance of protecting private lands from being taken over by eminent domain for the sole purpose of economic development.

The Grange supports the English language as the official language of the United States. Significant action needs to be taken to curtail robot call intrusions.

The New York State Grange and its local units will continue to collaborate with our Congressional delegation to speak for the good of rural America.

AIRLINES/AVIATION

AIRLINE PASSENGER BILL OF RIGHTS

We support "passenger rights legislation" that would provide passengers aboard a flight that has been delayed from takeoff for more than one hour with electricity for fresh air and lights, adequate food and drinking water, and working toilets. (2023)

UNMANNED AERIAL VEHICLES

We urge the United States Government to continue to proceed on a path of transforming America's armed forces into a modern force expanding our military capabilities using unmanned aerial vehicles. (2023)

BANKING/FINANCIAL INSTITUTIONS

ELIMINATION OF SELECT UNITED STATES CURRENCY

We favor the continuation of the penny and dollar bill in United States currency. (2021)

FEDERAL BAILOUT OF BANKING INDUSTRY

We support federal legislation/regulations to prevent the manipulation of United States financial institutions and support the investigation and prosecution of persons and entities that lead to the collapse of these institutions. (2023)

MANDATED ELECTRONIC BILLING AND PAYMENTS

We support empowering the newly created Consumer Financial Protection Bureau (CFPB) to ban banks, mortgage lenders, credit card companies and any other consumer financial institutions from charging consumers fees for paper statements. (2020)

PEER-TO-PEER PAYMENT APPS

We support legislation that would strengthen consumer protection for peer-to-peer payment app users by requiring providers to clearly state which security protocols are used to protect users' information, be transparent about the availability of Federal Deposit Insurance Corporation insurance, clearly explain reimbursement policies in cases of fraud or error, collect only the data needed to prevent fraud and provide the payment service, disclose and identify who they share consumer data with and the purpose for sharing the data, allow users to see their personal data and delete it if they no longer want to use the service, and do not require users to agree to finding arbitration to resolve disputes or to resolve claims on an individual basis. (2023)

BUSINESS CONCERNS

COMPANY TAX EVASION

We request federal legislators to pass legislation that would make it illegal for a United States business licensed and chartered in the United States to have a post office box address located in an offshore country as the legal location of that business while the physical business is in the United States (for the purpose of tax-exempt status). (2023)

EXCESSIVE HEAT IN THE WORKPLACE

We support proposed rule that would protect workers from excessive heat in the workplace, thus requiring employers to develop an injury and illness prevention plan to control heat hazards in workplaces affected by excessive heat. The plan would require employers to evaluate heat risks and, when heat increases risks to workers, implement requirements for drinking water, rest breaks, and control of indoor heat. It would also require a plan to protect new or returning workers accustomed to working in high heat conditions. (2024)

KEEPING AMERICA WORKING

We oppose the practice of businesses relocating to other countries for cheaper labor and operating costs and urge the United States Congress to do all in its power to encourage and assist businesses and manufacturing firms to remain in the United States, thereby retaining their jobs for American citizens. (2022)

CHILDREN

BABY TOURISM

We support legislation that would cease the "automatic granting of citizenship" to any child born to foreign nationals while touring/visiting the United States. (2020)

CHILDCARE FOR POLICE OFFICERS ACT

We support the Providing Children for Police Officers Act or similar legislation. (2024)

IDENTITY THEFT

We support legislation that would allow children's Social Security numbers and other private information to be frozen by the child's legal custodian in the same manner as adults to protect them from identity theft. (2024)

CONSUMER ISSUES

DO NOT CALL REGISTRY

We urge the Federal Government strengthen the "Do Not Call Registry" restrictions to prevent annoying phone solicitations. (2021)

FORCED ARBITRATION INJUSTICE REPEAL (FAIR) ACT

We support legislation that would prevent companies from imposing forced arbitration as a precondition for buying a product or using a service, and instead, allow consumers to choose arbitration willingly to settle a dispute or opt to have their dispute heard in a court of law. (2021)

PERSONALIZED PRICING

We oppose the use of personalized pricing without consumer and public awareness. (2022)

POWDERED ALCOHOL

We support legislation that would ban the sale of powdered alcohol. (2024)

PROTECTING YOUR GENETIC DATA

We support legislation that would update the definition of "genetic" testing to include direct-to-consumer commercial genetic testing companies, forbid the use of a person's genetic data without their consent, and ensure that such data is stored securely. (2023)

STOP TIP OVERS OF UNSTABLE, RISKY DRESSERS ON YOUTH (STURDY) ACT

We support legislation that directs the Consumer Product Safety Commission to adopt a stronger, mandatory stability standard for clothing storage units within one year of enactment. Such standards must include specified testing related to top overs, including an increased weight limit to simulate children up to six years old, testing under real world conditions such as climbing, carpeted floors and open drawers, inclusion of smaller clothing storage units, and new, strengthened warning requirements for all such products entering the United States market. (2021)

TELEPHONE PRIVACY

We support legislation that would prohibit telephone companies from releasing personal account records to third parties except law enforcement agencies. (2021)

We support legislation that prohibits companies from selling an individual's private and/or cell phone numbers to telemarketers without the individual's consent. (2021)

ELECTED OFFICIALS/ELECTIONS/CAMPAIGNS/VOTING

ELECTION REFORM

We stand behind a National Election Standard showing proof against fraud, and ease of operations and clarity of results. Said standard would leave the exact methods to the various states if the standards were met. (2021)

ELECTORAL COLLEGE SYSTEM

We strongly support the continued use of the Electoral College system to elect the President of the United States and urge that any action on state and national levels to abolish the Electoral College be opposed by New York State Grange and the National Grange. (2021)

FEDERAL CONGRESSIONAL TERM LIMITS

We support enactment of legislation that imposes term limits for Representatives and Senators in the Congress of the United States. (2021)

GENERAL ELECTION DAY

We oppose any legislation that would move the general election from the traditional Tuesday in November to a weekend day. (2021)

POLITICAL ACTION COMMITTEE FUNDS

We urge the Federal Government to pass legislation that would immediately freeze the Political Action C committee. (P.A.C.) funds of a political candidate when that candidate announces withdrawal from the campaign and that all eligible expenses (those incurred before the date of the candidate's withdrawal) must be submitted and paid within 90 days of the withdrawal, at which time remaining funds will be returned to the P.A.C. (2022)

PRIMARY ELECTIONS

We oppose cross party votes during a presidential primary election and that there be one set date for a National Presidential Primary Election Day. (2020)

RECORDED TELEPHONE POLITICAL MESSAGES

We urge the Federal Government to pass legislation that will place recorded telephone messages from political candidates and political action committees under the "Do Not Call" provisions. (2022)

REFORM OF CAMPAIGN FINANCE LAWS

We support reforming campaign finance laws to include campaigns that are limited to 4 months prior to the primary and general elections. (2020)

TRUST ACT

We support passage of the Transparent Representation Upholding Service and Trist (TRUST) Act which required members of congress and their family members to place certain assets into blind trusts and for other purposes. (2024)

VOTING RIGHTS ACT

We support the restoration of the Voting Rights Act of 1965 in its entirety so that states, counties, and municipalities with a history of discriminatory voting practices must obtain federal permission before changing voting procedures. (2024)

ENERGY/FUELS

FOSSIL FUELS

We support government investment in research conducted by the private and public sector that will lead to the development and implementation of alternative technologies that reduce dependence on fossil fuel products. (2020)

TRANSPORTATION OF NUCLEAR WASTE

We oppose the shipment of all grades of nuclear waste excluding low level medical radioactive waste on the St. Lawrence Seaway and to the importation of nuclear waste from foreign countries. (2020)

ENGLISH LANGUAGE

ENGLISH AS OFFICIAL LANGUAGE

We support English as the official language of the United States. (2021)

MULTILINGUAL SIGNS

We urge the New York State Legislature and the United States Congress to keep highway signs predominately in English only. (2020)

FOREIGN/INTERNATIONAL ISSUES

DEEP SEABED MINING

We request that the United States Government implement policies to prevent companies from deep seabed mining for cobalt, nickel, and other minerals/elements. (2023)

ENFORCEMENT OF IMMIGRATION LAWS

We support the federal government using money earmarked for lawsuits against the states they feel are in violation of the Supremacy Clause of the United States Constitution to properly enforce the existing Federal Immigration and Nationality Act to stop the influx of undocumented immigrants. (2021)

INTERNATIONAL MONETARY FUND

We ask our elected officials to more closely monitor how the International Monetary Fund (IMF) and other United States loans and grants to foreign countries are disbursed. (2024)

KYOTO LEGISLATION

We do not support Kyoto Legislation or any other legislation that would put the United States under the jurisdiction of the United Nations. (2022)

LAW OF THE SEA TREATY

We oppose ratification of the Law of the Sea Treaty which would give the United Nations control and jurisdiction over the world's bodies of water. (2024)

OCEAN SHIPPING LEGISLATION

We support legislation that would establish regulations requiring all shipping lines to change their ballast water in the open sea to curtail introduction of foreign species into our domestic waterways. (2020)

PROTECTION OF UNITED STATES ECONOMY

We support review of Congress on all trade and tariff policies with a view of protection for American agriculture, industry, and jobs. (2024)

THE IMPORT SECURITY AND FAIRNESS ACT

We support legislation that would address concerns related to the United State competitiveness by prohibiting goods from non-market economies, such as China, from benefiting from de minimum treatment and requires Customs and Border Patrol to collect more information on shipments, of any value, to make it harder for people to import illegal goods and harmful products. (2023)

UNDOCUMENTED IMMIGRANTS

We urge the United States Government to have the immigration laws strictly enforced including the deportation of undocumented immigrants. (2020)

UNITED STATES AGREEMENTS OR TREATIES WITH THE UNITED NATIONS

We strongly oppose the United States government getting involved with agreements or treaties with the United Nations or any other international body that takes away individual rights guaranteed under the Constitution or Bill of Rights or that imposes taxation on the citizens of the United States. (2020)

UNITED STATES/MEXICAN BORDER

We support more stringent patrols of the United States/Mexican border. (2022)

GOVERNMENT/ PROGRAMS/FUNDING

EMERGENCY FUNDING

We support legislative action that would make all emergency funding legislation automatically exempt from any other non-related legislation and pork barrel funding proposals. (2023)

FEDERAL MANDATE RELIEF

We call upon the President and Congress to enhance the Unfunded Mandates Reform Act of 1995 (Public Law 104-4) to fully fund Federal programs administered at the state and local levels. (2023)

FOOD AND DRUG ADMINISTRATION RESPONSIBILITIES

We seek legislation that would focus the Food and Drug Administration's (FDA) priorities on regulating and policing foods and drugs for human consumption and that some of the FDA's responsibilities be passed on to other departments such as Agriculture, Health, and Homeland Security. (2023)

FOREST FIRE FUNDING

We support legislation that would provide funding for major wildfires the same as other disasters through emergency funds so that The Forest Service prevention programs are not raided. (2022)

OFFICE OF RURAL PROSPERITY

We support the formation of the Office of Rural Prosperity to be housed within the Executive Branch of the President of the United States with the purpose to coordinate and streamline federal investments and foster public-private partnerships that strengthen communities and improve the quality of life and well-being of persons living and working in rural communities. (2022)

REPARATION PAYMENTS TO SLAVE DESCENDANTS

We urge our United States Senators and Representatives to refrain from passing legislation that would make the United States Government responsible for making reparation payments to descendants of slaves who worked in the United States. (2022)

THE OLDER AMERICAN REAUTHORIZATION ACT

We support the passage of the Older American Reauthorization Act of 2016 which amends the Older Americans Act of 1965 to reauthorize through fiscal year 2024 appropriations for the Administration on Aging, including Eldercare Locater Service, pension counseling services, information programs, grants for state and community programs on aging, grants and contracts for educational activities, Older American community service employment programs and grants for Native Americans. (2024)

GUN CONTROL/REGULATIONS

BUMP STOCKS/HIGH-CAPACITY MAGAZINES

We support legislation that forbids the use of bump stocks or high-capacity magazines and firearms. (2023)

CELL PHONE GUN

We support legislation that would prevent the production of handguns that look like cell phones. (2021)

HANDGUN RECIPROCITY

We oppose any legislation that would establish handgun reciprocity between states. (2022)

HOMELAND SECURITY

AGRICULTURAL BIOSECURITY

We urge Federal legislators to pass legislation on the following:

- (1) increase investment in the Diagnostic Laboratories throughout the United States to ensure biosecurity for agriculture
- (2) increase penalties for bioterrorism
- (3) increase funding for research into control and/or eradication of diseases that may be used by bioterrorists to disrupt our food supply. (2023)

CYBERSPACE THREATS

We urge Congress to appropriate the necessary funding to combat the continuing cyberspace warfare threats to the United States. (2023)

We support legislation that would establish a collaborative committee that would do research and development on how to rapidly identify, respond to and deter all future cyber-attacks. (2023)

ECO-TERRORISTS

We favor legislation that would encourage the criminal justice system to prosecute eco-terrorists as violent criminals. (2021)

HUMAN TRAFFICKING

HUMAN TRAFFICKING

We encourage more aggressive enforcement of existing Human Trafficking Laws and recommend that Grange members should use resources to educate themselves and others about the dangers of human trafficking. (2020)

We support legislation that would require a standardized training program for lodging industries that addresses the nature of human trafficking; how it is defined in state law; how to identify trafficking victims, relief, and recovery options for survivors; and social and legal services available to victims. The legislation would also require all lodging facilities to post signs, in a visible place, spelling out what human trafficking is and how to get help by contacting the National Human Trafficking Resource Center hotline. (2022)

INTERNET/TELEVISION/TELEPHONE/RADIO

BROADCAST COVERAGE BY CABLE/SATELLITE SYSTEMS

We support legislation to authorize the Federal Communications Commission to adopt rules that allow for interim carriage of local stations when there is an impasse in negotiations for renewal of retransmission or must carry agreements. (2024)

EMERGENCY FREQUENCY RADIO TRANSMISSIONS

We support legislation that would make the act of intentional radio jamming of emergency radio frequencies a criminal offense and that this crime is punishable by up to 10 years in prison and a \$10,000 fine, in addition to any civil penalties. (2024)

EXPEDITING BROADBAND SERVICES

We support the "American Broadband Deployment Act of 2023" or similar legislation that would streamline federal, state, and local permitting and regulatory reviews to expedite the deployment of communications facilities regarding the placement, construction or modification of personal wireless service facilities. (2024)

LANDLINE TELEPHONE SERVICE

We support legislation that would authorize and require the Federal Communications Commission to impose on internet-based telephone service the same basic service requirements that are required to be provided by the traditional copper wire-based telephone system. (2024)

ROBOT CALL EPIDEMIC

We support legislation that would strengthen the existing Telephone Consumer Protection Act (TCPA) of 1991 by making fines for intentional robot calling violations larger and ensuring that telephone companies implement new technology that is being developed to identify calls as potentially fraudulent so that consumers can decide whether to answer them. (2024)

TELEVISION, ENTERTAINMENT, AND RADIO VIOLATIONS

We support substantial increases in penalties for Federal Communication Commission violations in the transmission of obscene, indecent, and profane language and images by television and radio broadcasters. (2024)

JUDICIAL ISSUES

EXPANSION OF UNITED STATES SUPREME COURT

We support the continuation of nine justices on the Supreme Court of the United States. (2022)

MISCELLANEOUS

CHEESEBURGER BILL LAWSUITS

We oppose anyone bringing a lawsuit against the fast-food industry claiming the fast-food industry is responsible for the claimant's obesity. (2024)

CONTROL OF SO-CALLED "BATH SALTS" TYPE COMPOUNDS

We support the efforts of the Federal Government, State Attorney General and state and local law enforcement officials to control the supply and dissemination of so-called "bath salts," "glass cleaner," and other synthetic compounds that cause psychotic episodes, etc. (2022)

FEDERAL CONSTITUTIONAL CONVENTION

We urge our New York state legislators to vote "No" to any proposal for a Federal Constitutional Convention and to share with others the inherent dangers in having one. (2022)

LITHIUM-ION BATTERY SAFETY

We urge policymakers to give the Consumer Product Safety Commission the authority and funding it needs to protect consumers from the dangers connected to poorly made lithium-ion and other types of high-energy batteries. (2023)

PERMANENT DAYLIGHT-SAVING TIME

We support efforts to bring about the elimination of biannual time changes, favoring permanent daylight saving time that allows more light in the later afternoon/evening hours, that the Department of Transportation claims show a reduced number of accidents because people are driving more in daylight hours, prevalence of crime is reduced as crime is more likely to occur when it is dark and provides more quality time for families with later daylight hours. (2023)

SYNTHETIC MARIJUANA

We support legislation banning the sale of synthetic marijuana also known as "Spice" or "K2" regardless of what chemicals are used to produce them and the name under which they are sold. (2023)

UNITED STATES MADE SOUVENIRS

We urge the National Parks Service and other national entities such as the Smithsonian Institution to purchase souvenirs, clothing, etc. made in the United States for resale in their gift shops rather than buying items from foreign markets for resale. (2021)

NATIVE AMERICANS

NATIVE AMERICAN LAND CLAIMS

We recommend the Federal Government ratify all treaties relating to Native American lands and, failing in their duty to do so, assume full responsibility for any monetary settlement through the courts to the Native American Nation with no inclusion of land. Any land to be purchased should be only from willing sellers with the same taxes and benefits accorded to all residential or business owners. (2024)

We urge our Congress to ratify any treaties in question with the Iroquois Confederacy, to enact a statute of limitations of not more than 40 years which will apply to the Federal Government and the Native American Nations, and to provide just compensation to the Native American Nations for an inadequacy in the payment they received when the land was sold to New York State. (2023)

PARKS

NATIONAL PARK FEES

We support legislation that would allow the federal government to charge fees for the use of the National Parks for producing movies, videos, ads, and commercials with the income to be used to maintain and make improvements to the National Parks and Monuments. (2020)

POSTAL SERVICE

POSTAL SERVICE CLOSING

We urge the United States Postal Service to proceed with caution in relation to the proposed Post Office closures, taking into consideration the special needs of the community as well as the statistical analysis developed for closure criteria. (2021)

SATURDAY MAIL SERVICE

We oppose the elimination of Saturday mail delivery by the United States Postal Service (USPS). (2020)

UNITED STATES POSTAL SERVICE (USPS) EMERGENCY FUNDING

We urge Congress to provide emergency funding for the United States Postal Service so that it can continue to provide essential services to the American public, especially to the needs of rural America and that Congress prohibit the Postmaster General from implementing ANY further incapacitating changes to their operation standards until the pandemic has ended. (2020)

PRAYER/PATRIOTISM/FREEDOMS

FLAG CODE

We encourage our government officials and school officials review the United States Flag Code, Title 4, Chapter 1, to promote more respect for the American Flag. (2022)

MEMORIAL DAY

We support the passage of the legislation, originally introduced by Senator Daniel Inouye of Hawaii, which would restore the original Decoration Day to May 30th of each year, restoring the recognition our veterans deserve for the sacrifices they have made on behalf of our nation. (2023)

PATRIOT ACT

We urge the federal government to amend those parts of the Patriot Act which infringes on United States civil liberties and civil rights. (2023)

PLEDGE OF ALLEGIANCE IN THE UNITED STATES SENATE

We believe that the members of the United States. Senate should recite the Pledge of Allegiance out of respect for those who have fought for and, in many cases, died for the benefits that the Constitution of the United States has guaranteed for all the citizens of the United States. (2024)

REMOVAL OF "GOD" FROM PLEDGE OF ALLEGIANCE AND CURRENCY

We object to the removal of "One nation under God" from the Pledge of Allegiance and "In God We Trust" from our United States currency. (2024)

PROPERTY OWNERS' RIGHTS

LIMITATION OF EMINENT DOMAIN

We support the passage of legislation to protect private lands from being taken over by eminent domain for the sole purpose of greater economic revenue. (2021)

We urge the United States Congress to pass legislation which will give property owners some protection from the expanded scope of eminent domain procedures. (2020)

PUBLIC EMPLOYEES

PERFORMANCE BONUSES

We support legislation that would eliminate the practice of awarding performance bonuses to any elected or appointed Federal public service employees. (2024)

SOCIAL SECURITY/PENSION PLANS

BENEFITS FOR TERMINALLY ILL

We support proposed legislation for expediting Social Security benefits by eliminating the fivemonth waiting period for patients with terminal illnesses. (2022)

EARNING LIMITS

We support federal legislation that would substantially raise the Social Security earning limit for individuals. (2022)

FRAUDULENT USE OF SOCIAL SECURITY NUMBERS

We support legislation that would help stop the unauthorized sale of Social Security numbers and increase the penalties for fraud that involves the use of another person's Social Security number. (2020)

SAFEGUARDING SOCIAL SECURITY

We support that top priority be given to ensure continued funding of Social Security, sufficient for future generations, and without drastically increasing the eligibility age. (2024)

We strongly support that any monies in the Social Security fund be used only for Social Security purposes. They should not be used by other agencies/departments or be put in a general fund to help balance the budget. (2021)

SUPPLEMENTAL SECURITY INCOME (SSI) PROGRAM REFORM

We support legislation that would update the Supplemental Security Income (SSI) Program to increase asset limits and earnings to be in line with today's economy and to tie future increases to the rate of inflation. (2023)

UNDOCUMENTED IMMIGRANTS

We support legislation such as the "No Social Security for Undocumented Immigrants Act" or similar legislation that would permanently terminate plans to use Social Security funds to support undocumented immigrants. (2024)

TOYS

COLOR OF TOY WEAPONS

We recommend that toy retailers do not sell toy weapons with the appearance of a real weapon. (2021)

CONSUMER PRODUCT SAFETY

We support legislation that will exempt United States artisan made toys and homemade articles from third party testing as required by the "Consumer Products Safety Improvement Act" of 2008. (2024)

TRANSPORTATION/ROADS

DEVELOPING RESPONSIBLE INDIVIDUALS FOR A VIBRANT ECONOMY ACT (DRIVE-SAFE ACT)

We support legislation that would remove the age restriction on interstate transportation by licensed commercial drivers. Implementation of additional training programs once a driver qualifies for a commercial driver's license where drivers must complete at least four hundred hours on on-duty time and 240 hours of driving time in the cab with an experienced driver. Such training is to be completed in trucks equipped with new safety technology including active braking collision mitigation systems, video event capture, and a speed governor of sixty-five miles per hour or below. (2020)

OCEAN SHIPPING REFORM ACT OF 2021

We support passage of the Ocean Shipping Reform Act of 2021 or similar legislation. (2022)

OPPOSITION TO A NATIONAL SPEED LIMIT

We oppose a national speed limit and oppose commissioning a study to determine the optimal speed limit. We favor energy-saving options including:

- 1. Use of public transportation
- 2. Promotion of carpooling
- 3. Better enforcement of current speed limits
- 4. Promotion of alternative fuel development (2023)

UNDERRIDE CAR CRASHES

We highly encourage the Department of Transportation require trucking companies use the newer and stronger rear guards, along with the front and side guards on the semi-trailers to help prevent underride car crashes by small cars when involved in a traffic accident. (2021)

VEHICLES

ALL-TERRAIN VEHICLE (ATV) AND UTV

We support a renewed effort be made by public health officials, the all-terrain vehicle industry, and the United States Consumer Protection Safety Commission to work with individual states to increase helmet use through a combination of stricter policy enforcement and better education to help in the reduction of ATV injuries by children younger than 18. (2021)

We support legislation requiring all manufacturers to install a rollover device on all new recreational off-road vehicles. (2022)

ANTIQUE/VINTAGE CARS

We oppose any Federal Scrappage legislation which will require the scrappage of vehicles over 15 years old. (2022)

AUTO/TRUCK HEADLIGHTS

We urge National Grange to work with the National Safety Council, the Department of Transportation, and Federal legislators to address the safety issue of high intensity lights and the safety concerns for drivers in oncoming traffic with the auto and truck light manufacturers and auto and truck manufacturers. (2023)

"KILL SWITCH" OPPOSITION

We oppose any state or federal mandate that would require automobile manufacturers to implement camera and/or sensor tracking of drivers to allow or disallow operation of an

automobile, except in cases where a person has been properly convicted of a related offence and has had such imposed as part of their lawful sentence, (2024)

We support the repeal of any exiting mandates requiring technology to allow or disallow operation of an automobile, except in cases where a person has been properly convicted of a related offense and has had such imposed as part of their lawful sentence. (2024)

HOT CARS ACT OF 2021

We support current or similar legislation such as the "Hot Cars Act of 2021" that would require all new passenger motor vehicles to be equipped with a system that detects the presence of unattended occupants and engages a warning to reduce death and injuries to children and/or animals. (2022)

VETERANS/MILITARY ISSUES

ARLINGTON NATIONAL CEMETERY ELIGIBILITY REQUIREMENTS

We support legislation that would direct the Department of Defense to ensure the next National Cemetery provides full military honors and leaves unchanged the current eligibility requirements earned through military service. (2022)

ARMED FORCES RETIREMENT HOME

We support legislation that would increase the active-duty service member's deduction to \$1.00 per month from their monthly paycheck and revising the fee structure with any additional shortfall in fund balance being subsidized by the Department of Defense with no reduction in current veteran activities, to include golf courses. (2022)

BLUE WATER NAVY VIETNAM VETERANS ACT OF 2018

We strongly support legislation to amend the Blue Water Navy Vietnam Veterans Act of 2018 by eliminating the nautical mile limitation to include United States Navy and Marine Corps veterans who were assigned to the Vietnam theater of combat operation or received the Vietnam Service medal. (2023)

BURN PITS IN SOUTHEAST ASIA

We support legislation that would amend the Pact Act to include exposure to the air borne hazards causing severe clinical irregularities among Vietnam War veterans. (2023)

CHILDCARE FOR MILITARY FAMILIES

We support the "Availability of Childcare for Every Service Member and Spouse Act" (ACCESS) or similar legislation. (2022)

FEMALE VETERAN PEER COUNSELING

We support legislation that would direct the Veterans Affairs Secretary to assist female veterans in reintegrating in their communities after discharge from the Armed Forces. (2023)

MAJOR RICHARD STAR ACT

We support passage of legislation that would eliminate the offset of military retirement pay and Veterans Administration (VA) disability pay. (2023)

MILITARY AVIATION ACCIDENT RESOLUTION

We support legislation that would provide the funds necessary to put military readiness back where it needs to be, to deliver a readier force which in turn will help decrease military aviation accidents. (2023)

MILITARY ELECTION BALLOTS

We support the development of a mechanism for counting all military absentee ballots. (2021)

MILITARY EQUIPMENT

We urge Congress to require government contractors to utilize United States made components and subsystems in construction and repair of military equipment over those made by foreign subcontractors for use by the United States Armed Forces to ensure the defense of our country as well as the employment of United States citizens at subcontractor facilities. (2023)

MILITARY MEDALS RANKING

We urge the Federal Government to legislate the Department of Defense, should it develop new military medals (e.g. Distinguished Warfare Medal, now defunct, for cyber warriors and drone pilots) be placed in the Military Order of Precedence under those medals that can only be earned in direct combat (e.g. Bronze Star Medal with Combat "V" and the Purple Heart). (2023)

MILITARY RETIREE BENEFITS

We urge the Federal Government to include in all future Status of Forces Agreements negotiated, renegotiated, or revised with host countries that retired United States military members and their dependents be allowed to use United States military facilities such as post and base exchanges, commissaries, healthcare, mail, recreational facilities, etc. (2023)

MILITARY SPOUSE ACT

We support legislation that would amend the general business laws, the insurance laws, and the real property laws that would enable the transfer of valid professional licenses of military spouses from out-of-state enabling them to seek employment in his/her chosen career in their new home state. (2022)

NATIONAL GUARD/RESERVES RETIREMENT BENEFIT FAIRNESS

We urge Congress to amend the law to retroactively allow early retirement for those Reserve and National Guard members who have completed 20 years of service and had been activated to Active Federal Duty since August 2, 1990, the same military benefits as those who began in 2001. (2023)

PENSION BENEFITS FOR MEDAL OF HONOR RECIPIENTS

We support legislation that would increase the monthly pension of Medal of Honor recipients to \$3,000. (2021)

POST 9/11 BILL STIPEND FOR CHILD(REN)

We support legislation that would keep the child(ren) post 9/11 GI Bill stipend at its current level, a promised benefit when the military sponsor re-enlisted. (2021)

PROSECUTION OF GRAVE DEFILERS

We support legislation to make it a federal offense to defile the grave of any service member, regardless of where the grave is located. (2023)

SELECTIVE SERVICE

We support retention of the Selective Service System. (2024)

STOP STOLEN VALOR FOR SERVICE-DISABLED VETERAN OWNED SMALL BUSINESS CONTRACTORS ACT

We support passage of the Stop Stolen Valor for Service-Disable Veteran-Owned Small Business Contractors Act or similar legislation. (2023)

SUPPORT FOR THE MEMBERS OF OUR ARMED FORCES

We voice support to the men and women in the armed forces and to their families for their dedication and sacrifices. (2022)

"UP OR OUT" RULES FOR MILITARY PERSONNEL

We support legislation that would end "up and out" rules for all military personnel that have not advanced to a higher rank within the prescribed period. (2021)

VETERANS ADMINISTRATION CLAIMS BACKLOG

We urge the Department of Veterans Affairs to efficiently use their resources to resolve the serious backlog of veteran's benefit claims. (2023)

VETERANS ADMINISTRATION EMPLOYEE BONUSES

We support the suspension of bonuses to all Veterans Administration employees involved in claim processing for compensation and pension benefits until such time as the claims backlog has been eliminated and the processing time for veterans' claims has been reduced to 120 days and that the money saved by eliminating performance bonusses be used for the medical care of our veterans. (2024)

VETERANS AFFAIRS MORTGAGE PROTECTION

We support legislation that would extend the Veterans Administration Mortgage Protection Life Insurance, to all service-connected veterans who are rated as permanently and totally disabled. (2023)

VETERANS' DAY OBSERVANCE

We oppose legislation that would change Veterans' Day from November 11th. (2022)
